Trunk or treat was a success. 19 vendors supplied candy to approximately 700 children. Veteran's Day will be celebrated November 11, 2017 beginning with a parade at 10:00 a.m. and a ceremony in the Jena Town Park at 11:00 a.m. The Downtown Block Party will be held November 16th beginning at 5:00 p.m. The Strand Theater is very close to being finished. The Senior Citizen's Christmas Dinner will be held Friday, December 1st at the First Baptist Church. The Christmas Parade will be held December 8th. This year's theme is "I Believe". The Town Square renovation project is underway. The fence is being moved and picnic tables, benches, umbrellas and trash cans are being put together to be moved to the expanded location. The Jena High School football team had a 10-0 regular season and will start the playoffs this Friday with a home game against Westlake High School. We are all very proud of our team and coaches. Sales tax collections for October 2017 were \$77,240.19 compared to 2016 collections of \$81,085.16.
