Donny Richardson abstained from voting due to conflict of interest. Councilmen Chapman, Wilson & Sandifer voted for. Motion passed.

Assistant Fire Chief Charlie Savell presented the fire report.

Police Chief Scott McLendon presented the police report.

Superintendent David Miller presented the utility report.

Mayor Edwards announced that the Town Hall renovations are nearing completion. The Third Street project is on schedule to be bid by the State. The balcony seating for the Strand Theater has been ordered. The 3rd Annual Easter in the Park celebration was a total success. Thank you to the local churches, organizations, and groups for making the day run smoothly. Thank you to our employees for hanging the eggs at the park. Also thank you to Josh Corley & Robert Warwick for assisting the Jena PD with the trees that were blown down during the storm. Our departments always work together to get any task successfully completed and I am thankful for their teamwork. Sales tax collections for March 2018 were \$70,967.58 compared to 2017 collections of \$73,674.08. In total Jena collected more sales tax during the first quarter of 2018 than in 2017.

As there was no other business to be brought before the Mayor and Town Council, Mr. Richardson made a motion seconded by Mr. Wilson to adjourn the meeting. The meeting was adjourned at 6:24 p.m.
